## Targeted Call for Speakers on Value-Based Models for Care and Reimbursement

**Deadline: Sunday, July 15, 2018 at 11:59 pm EDT**

The Academy of Managed Care Pharmacy (AMCP) is now accepting proposals for education program speakers on ***value-based models for care and reimbursement*** for AMCP Nexus 2018, which will be held October 22-25, 2018 at the Orlando World Center Marriott, Orlando, Florida.

Selected speakers will be featured in a new education opportunity being offered at AMCP Nexus 2018 titled, “AMCP Talks: Solutions for Value-Based Care and Reimbursement.” This 3-hour program will feature rapid-fire, timed presentations followed by a moderated panel discussion with audience participation. The programming will be divided into the following three topics related to value-based care, and applicants will be required to select one of these topics for their submission:

- **Approaches to value-based arrangements**  
Speakers will present unique contractual relationships to enable delivery of value-based care and/or innovative managed care services, including but not limited to outcomes-based contracting, organizational restructuring, innovative benefit designs, and integrated service models.
- **Approaches to value-based care management**  
Speakers will present on using data integration and analysis to track outcomes of care; including but not limited to approaches to measure and track total cost of care, network provider performance as well as clinical outcomes of care.
- **Approaches to value-based patient engagement**  
Speakers will discuss strategies to engage patients in their care to optimize outcomes; including but not limited to remote patient monitoring, MTM service delivery, adherence interventions, patient incentive programs, models for shared decision-making.

Speakers will be asked to speak for 10 minutes on their topic and participate in a 20-minute panel discussion, followed by an audience question and answer period.

**AMCP is specifically looking for individuals from all practice settings who can present approaches to successful value-based contracting arrangements, care management and patient engagement. There will be special consideration given to speakers and organizations that are utilizing the application of health information technology and analytic tools to streamline and optimize the process for managing value-based arrangements. Preference will be given to presentations with data demonstrating the success of their solution.**

*AMCP Nexus 2018: Preparing for the Next Generation of Care* is expected to attract approximately 2,500 managed care pharmacists and other health care professionals seeking to increase their knowledge of the management and coordination of clinical, pharmacy benefit, and pharmacy care programs. Programming will address topics in five tracks ranging from specialty management, managed care research, legislative and regulatory issues and preparing for the next generation of care.

Interested individuals must also meet the following criteria:

- Available to attend Nexus 2018 in Orlando, Florida from October 22-25, 2018
- Willing and able to discuss your organization's implementation of value-based care and reimbursement
- Able to present a session that provides the participant with "actionable" strategies that can be used in their own practice.

- Complete speaker information including name, title, email address and phone number
- Topic area (select one):
  - Approaches to Value Based Arrangements
  - Approaches to Value Based Care Management
  - Approaches to Value Based Patient Engagement
- Brief summary of the presentation that includes responses to the following questions:
  - What was the unique challenge you encountered?
  - How was your challenge addressed?
  - What did you learn and how can others benefit?
  - Was there a specific health IT or analytic tool used?
  - Do you have any data to support your outcomes that can be shared?
- What specifically will session participants learn from your presentation?

**Proposals for speakers focused on value-based care and reimbursement must be submitted no later than 11:59 pm EDT on July 15, 2018. Notification of submission status will be made by August 15, 2018.**
