
## AMCP Foundation Announces Summer Interns with Pfizer,


## Chapter Spotlight: University of Washington's P&T Competition


**What was the most challenging aspect of P&T, and how did your group handle it?**

## Dymaxium ISPOR Workshop in Boston: Challenges of Providing Information to Payers Prior to Product Launch

Payers and other decision makers are keen to receive information about new products prior to launch, in order to help with financial planning or to anticipate the nature of the clinical and economic assessment they may have to perform. However, manufacturers face challenges in providing this information, either because it may breach regulations concerning the communication of 'off-label' information, or because the information available is preliminary or otherwise subject to uncertainty. These issues were discussed, informed by a recent survey of 172 US

payers, which explored the types of information they require, the time by which they require it, and the means by which such information might be exchanged. Discussion leaders addressed these challenges from the perspectives of payers, manufacturers, and pharmacoeconomic researchers. Audience participation was encouraged by conducting an interactive survey of opinions on the key issues, followed by a general discussion. 
