



President Biden Signs American Rescue Plan Act

On March 11, the one-year anniversary of the COVID-19 global pandemic declaration, President Biden signed into law the \$1.9 trillion [American Rescue Plan Act of 2021](#), providing further relief to Americans facing the economic and health impacts of the pandemic. The American Rescue Plan provides direct payments of \$1,400 to individuals making up to \$75,000, \$350 billion in aid to state and local governments, \$210 billion to K-12 schools, colleges, and childcare providers to assist with safely reopening, and nearly \$70 billion for COVID-19 vaccine and mitigation efforts. The measure also grants an additional \$300 billion in weekly jobless benefits through September, an expanded tax credit of up to \$3,600 per child, \$50 billion to small businesses, and \$29 billion to small and mid-sized restaurants. Finally, the bill expands the Affordable Care Act through broader subsidy eligibility for all incomes and incentivizes states to expand Medicaid.

AMCP Signs Medicaid Stakeholder Letter to Congressional Leaders

On Feb. 18, AMCP [joined](#) the Modern Medicaid Alliance (MMA) in urging Congress to strengthen the Medicaid program in the next COVID-19 response bill by increasing the Federal Medical Assistance Percentage (FMAP) rate by at least 12 percentage points. From February to September 2020, Medicaid and CHIP enrollment has increased by more than 6 million people, or 8.6% nationwide. Without increased funding for Medicaid, many beneficiaries could be denied access to the essential care they need and deserve. The MMA's request is in line with the position of the bipartisan National Governors' Association.
