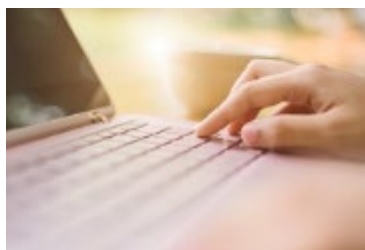

AMCP Publishes New Pay-for-Performance Principles

On Dec. 14, AMCP announced its support of the use of payment arrangements for pharmacists that include performance-based metrics related to the services they provide. AMCP supports value-based payment models that incentivize improvement in patient outcomes. To help guide how such models can be implemented in a way that benefits all parties and, most importantly, improves patient care, the AMCP Board of Directors recently approved a pay-for-performance principles document entitled Performance-Based Reimbursement and Direct and Indirect Remuneration (DIR) Fees
