AMCP is seeking feedback on its latest update to the [Format for Formulary Submissions, Version 4.1](#), which aligns with recent [FDA Final Guidance](#) on communications of health care economic information (HCEI) on unapproved products. The draft *Format*, Version 4.1 explains how to present information and evidence throughout the continuous life-cycle of products in the following areas: pre-approval product dossier, post-approval product dossier, and unapproved indication dossier. [Please use the survey](#) to provide feedback by **June 17**. AMCP plans to release *Format*, Version 4.1 in late 2019.

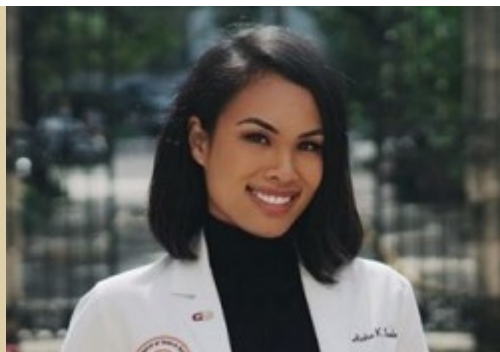
