Nexus 2018 Is a Wrap; Nearly 2,500 Attendees Gathered to Prepare for Next Generation of Care





Nearly 2,500 managed care pharmacy professionals from across the country gathered in Orlando, Florida, Oct. 22-25 for AMCP Nexus 2018. The conference, with the theme of Preparing for the Next Generation of Care, featured more than 30 educational sessions and many ancillary programs covering the trends and emerging models affecting the practice of managed care pharmacy today and into the future.

The educational programming was divided into five tracks: (1) Preparing for the Next Generation of Care; (2) Drugs, Diseases and the Managed Care Impact; (3) Legislative and Regulatory Trends: From Rhetoric to Practice; (4) Managed Care Research in Action; and (5) Specialty Management: Keeping Up with Runaway Innovation. This year's General Session keynote speaker was Mick Ebeling, a health care technology entrepreneur and philanthropist. Ebeling is founder of Not Impossible Labs, a company committed to creating technology for the sake of humanity.

Nexus 2018 also included 12 satellite symposia on diverse issues affecting health care; an Exchange hall featuring nearly 50 exhibitors presenting the latest ideas, tools and advancements, and more than 300 posters on the latest research; 9 Science & Innovation Theaters and Industry Workshops providing additional deep-dives into managed care pharmacy issues; and programs designed specifically for student pharmacists. In addition, Nexus 2018 featured the AMCP Foundation 8th Annual Research Symposium titled "Trends in Health Care: Disruptors and Opportunities.

New this year was AMCP Talks, an innovative education opportunity that mixes short, focused presentations with interactive panel discussions (image right). AMCP Talks focused on value-based care and potential solutions to the biggest challenges in implementing value-based care management tools and contracts.

AMCP Foundation's 8th Annual Research Symposium Discusses Health Care Trends, **Disruptors and Opportunities** 

Misaligned incentives that drive overutilization of certain treatments, a realization that everyone can't have everything on demand, and the need to address social determinants to improve patient health were among the health care trends revealed at the AMCP Foundation's 8th Annual Research Symposium last month.

Nexus 2018. The Symposium engaged national health care thought leaders on new

findings from the Foundation's ongoing research into trends, challenges and

opportunities facing stakeholders across the health care landscape.





At the event, the Journal of Managed Care and Specialty Pharmacy and the Foundation presented a special award to the senior investigator with the most outstanding abstract related to the Research Symposium theme. That distinction went to Karl M. Kilgore, PhD, Director of Advanced Analytics at Avalere Health, an Inovalon Company, who focused on "Social Determinants of Health: Aggregate Proxy Data and Granularity." Social determinants are identified by the Foundation as a global influencer impacting health care trends. Dr. Kilgore's study about using aggregate data to proxy individual-level socioeconomic characteristics in research on medication adherence offers practical insight on risk adjustment, proxy selection and the ability to predict health status.

It is a great honor to welcome everyone to Orlando and AMCP Nexus 2018. This large gathering is a testament to the vitality of our profession and the strength of AMCP. According to a recent poll by West Health Institute and the University of Chicago, 77 percent of Americans regard drug costs as "unreasonable." And 88 percent believe lowering medication costs should be a top priority for political candidates. Concerns over rising costs are backed up by CMS, which projects that spending on prescription drugs will grow 6.3% annually, from \$338 billion last year to \$605 billion in 2026. AMCP Partnership Forum Builds Infrastructure and Methodologies to Utilize PROs





A multimodal approach is needed to engage individuals in sharing patient reported outcomes (PROs) that can be used to advance objectives in value-based care and drug development, according to attendees of AMCP's Partnership Forum last month on "Building the Foundation for Patient Reported Outcomes: Infrastructure and Methodologies." Many health care stakeholders see the potential of PROs — such as self-reported changes in a disease state — to improve patient care and further the adoption of value-based care models. In addition, the FDA is expected soon to issue new draft guidance on incorporating PROs into the drug development and approval process. However, incorporating PROs within drug development and delivery of care has been difficult, in part due to the fragmented nature of the U.S. health care system. Read more

# Registration is Open for AMCP Foundation's 2019 P&T Competition

AMCP Student Chapters interested in competing in the 2019 P&T Competition must register their pharmacy school/college online with the <u>AMCP eDossier System</u> no later than **11:59pm EST on Monday, Nov. 12**. The study drug for the 2019 P&T Competition is TYMLOS® (abaloparatide) injection for subcutaneous use. TYMLOS is indicated for the treatment of postmenopausal women with osteoporosis at high risk for fracture defined as a history of osteoporotic fracture, multiple risk factors for fracture, or patients who have failed or are intolerant to other available osteoporosis therapy. The AMCP Foundation is grateful to Radius Health, Inc., for use of its dossier for TYMLOS for this competition. Beginning Nov. 13, student pharmacists participating on P&T Competition teams will need to register online with the AMCP eDossier System—Academia portal to gain access to the dossier. #### **Student Chapter Highlight: University of**

Mississippi

Earlier this year, University of Mississippi graduate students Sushmitha Inguva and Siddhi Korgaonkar, along with 3rd year pharmacy students Anna Crider and Mariah Cole, placed 3rd in the first Pharmacy Quality Alliance (PQA) Healthcare Quality Innovation Challenge. The challenge is designed to promote student engagement in leveraging technology to create solutions that improve healthcare quality measures. Student teams were asked to develop a business summary on a technology-enabled solution based on one of three prompts -statin use in diabetic patients, addressing potentially unsafe opioid use, or patient engagement with Medicare prescription drug programs. Sushmitha, Siddhi, Anna and Mariah focused on the prompt that addressed potentially unsafe opioid use/prescribing. Their business summary detailed an application that had access to prescription drug monitoring program (PDMP) data, which would be displayed in a manner that is customizable to the physician's specialty. Information displayed by the app included organized tabs that reported patient's providers, a list of opioids received with their morphine milligram equivalents and a link to CDC guidelines for opioid prescribing. The app also has the ability to flag potential provider



shopping, high morphine milligram equivalents and concurrent use of benzodiazepines. Their goal was to improve the accessibility and the feasibility of the PDMP to encourage providers to utilize its data. The team's proposal took 3 months to complete.
