AMCP Nexus 2019 Is a Wrap: Annual Fall Conference Attracts Record Attendance

A record 2,500-plus managed care pharmacy professionals from across the country attended [AMCP Nexus 2019](#) for four days of programming that focused on the “intersection of value and care.” AMCP’s annual fall conference took place Oct. 29–Nov. 1 at the Gaylord National Harbor, Md., just outside of Washington, D.C. Attendees learned the latest managed care pharmacy developments and best practices through nearly 30 educational sessions in five tracks. AMCP CEO Susan A. Cantrell, RPh, CAE (*pictured*), noted the pressure to enhance value and improve outcomes, while also addressing the rising costs of medications, has never been greater. “I’m pleased to say AMCP and our members remain at the forefront of developing solutions that allow patients to get the medications they need at a cost they can afford,” Cantrell said. “The

AMCP CEO Blog: PAs Play Crucial Role in Ensuring Appropriate Medication Use

Blog by AMCP CEO Susan A. Cantrell, RPh, CAE: As managed care professionals, we recognize that prior authorization (PA) is a crucial but often misunderstood utilization management tool. The bad rap that PAs have received recently, I believe, comes from misinformation about the process and challenges within in specific systems that can be corrected. This includes examples in [Dr. William E. Bennett Jr.'s Oct. 22 opinion piece](#) in the Washington Post, where he alleges PA “exists so that many patients will fail to get the medications they need.” We know this is certainly not the intent of a well-designed PA program for pharmaceuticals. PAs are not designed as a strategy to save money at the expense of patient care. Rather, we know that PAs help improve patient outcomes by encouraging the use of appropriate therapies with established evidence of efficacy and safety, and that provide the best value. A key theme running through the presentations was the increasing need for more effective data to improve decision-making and develop innovative patient care that enhances outcomes. "Our central commitment is to facilitate innovative research about the evolving health care environment," said AMCP Foundation Executive Director Paula J. Eichenbrenner, MBA, CAE (*pictured*). "It is especially timely that we convene around cancer care, with 1.73 million new diagnoses annually in this country, and a persistently high mortality rate, and nearly \$150 billion in healthcare expenditures related to oncology." 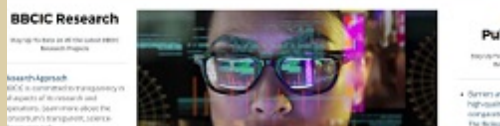

AMCP 2020 Call for Poster Abstracts Is Open

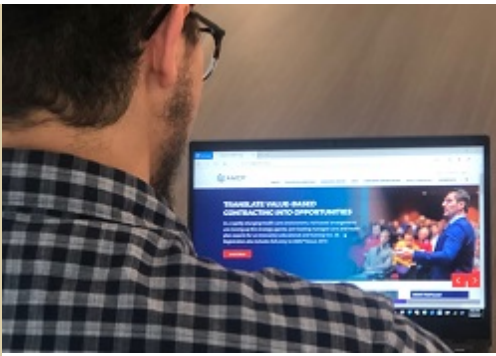
