AMCP applauds Senators Moore Capito (R-WV) and Shaheen (D-NH) and Congressmen Thompson (D-CA-5) and McKinley (R-WV-1) on the introduction of the bipartisan Access to Prescription Digital Therapeutics Act of 2022 ([S. 3791/H.R. 7051](#)). One of AMCP's top federal priorities, this bill will authorize coverage of prescription digital therapeutics (PDTs) by the Medicare and Medicaid programs.
