Like everyone across the country, AMCP members and staff share a deep concern for the safety and wellbeing of thousands of people displaced by Hurricane Harvey.

AMCP has 115 members in the Houston area, including employees of Cigna-HealthSpring, Kelsey-Seybold Clinic and students at Texas Southern University and the University of Houston. In addition, a staff member's family lives nearby, and the Southwest AMCP Affiliate originated in the Lone Star State, then known as the Texas Academy of Managed Care Pharmacy.



Our thoughts and prayers go out to everyone affected by this unprecedented storm and flood. This kind of disaster puts many of our daily troubles in perspective, and makes us realize the importance of coming together to help one another. We at AMCP are doing our part to address the massive need.

AMCP staff has so far collected more than 150 pounds of daily items, including diapers, baby food, pet food, canned goods, toiletries, socks and shoes. The collection was organized by our own Zain Madhani, AMCP Program Coordinator for Pharmacy and Government Affairs, and Student Development. Zain is from Houston, where her family still resides. # Seeking Feedback: Proposed Revisions to the Pharmacy Profession's MTM Definition

A <u>Joint Commission of Pharmacy Practitioners (JCPP)</u> Workgroup, comprised of 13 national pharmacy organizations, including AMCP, is seeking feedback on proposed revisions to the pharmacy profession's definition of "Medication Therapy Management (MTM)." Specifically, JCPP is requesting comments on the proposed draft definition, a proposed new term for the definition, and supporting text promoting the value of pharmacists in delivering the spectrum of services described in the definition.

To date, AMCP's position with significant input from its MTM Advisory Group, has been to support the use of Medication Therapy Management (MTM) as the appropriate term to describe the broad spectrum of cognitive services that pharmacists provide in multiple settings as it is defined in statute, understood by other health care providers and patients, and has been adopted in the marketplace in areas outside of Medicare Part D such as state Medicaid programs and the commercial market. However, others have raised concerns that while originally intended to be broadly applied in the marketplace, the term MTM is often associated primarily with Medicare Part D and therefore there is a need to update the terminology to create consistency and promote better understanding of the services pharmacists provide. The panel will be led by moderator **Alan Weil**, Editor-in-Chief of *Health Affairs*, and an elected member of the National Academy of Medicine. Among his previous positions, Weil served as executive director of the National Academy for State Health Policy (NASHP); he directed the Urban Institute's Assessing the New Federalism project; and he held a cabinet position as executive director of the Colorado Department of Health Care Policy and Financing, the state's Medicaid agency. The AMCP Foundation takes pride in presenting a wide range of stakeholder perspectives, including those outside of the managed care pharmacy arena. That is why the Foundation is delighted to feature Alan Balch, PhD, CEO of the Patient Advocate Foundation, at its 7th Annual Research Symposium: Value-Based Health Care: Identifying Benefits for Patients, Providers & Payers.

Dr. Balch, who will deliver the keynote address, is ideally suited to examine the focus of this event: "the patient's evolving role in health care, and how the value of care can be maximized for patients."



As CEO, Dr. Balch oversees a national non-profit organization that serves as a liaison between the patient and their insurer, employer and/or creditors to resolve insurance, job retention and/or debt crisis matters relative to their diagnosis. Dr. Balch has led numerous federal advocacy efforts at the legislative and regulatory level, including helping to organize and lead a coalition that successfully fought for regulatory improvements in the FDA's review of cancer drugs. Comparing Payers and Hospital Providers: Trend for Pre-approval Information Requests to Support Formulary Decisions

AMCP has been advocating for pre-approval information exchange between payers and manufacturers to support budget and formulary planning in an era of robust drug pipelines with promising yet costly treatments. Payers are now reviewing products up to 12-24 months in advance of FDA approval. This trend has been acknowledged with recent proposed legislation and a FDA draft guidance. In 2016, research with payers using the AMCP eDossier System indicated an increased need for the earlier exchange of information between manufacturers and payers. In 2017, Dymaxium expanded the research to determine if the trend for pre-approval information requests to support formulary decision making is the same for hospital providers. Read more.
