8:15am – 9:45am Breakout Session #3 - Innovating Benefit Design & Reimbursement Strategies for Precision Medicine

During this breakout session, forum participants will consider innovative benefit designs and reimbursement strategies for the coverage of precision medicines, including the development of models for precision medicines given that traditional population health models utilized by managed care pharmacy may not be applicable. Forum participants will consider the impact of precision medicine on current managed care pharmacy utilization management tools. In addition, forum participants will consider coverage and reimbursement for a pharmacist or other health care provider's time associated with analysis and evaluation of a patient's genomic sequencing and subsequent recommendations to the patient's medication regimen. Finally, Forum participants will discuss mechanisms for defining success with precision medicines, including the development of outcomesbased quality measures.

Precision Medicine

During this breakout session, forum participants will identify legal and regulatory barriers to the adoption of precision medicine from a managed care pharmacy perspective. Forum participants will discuss areas such as The Health Insurance Portability and Accountability Act (HIPAA) vs The Genetic Information Nondiscrimination Act (GINA), differing regulatory pathways for FDA approval, non-discriminatory formulary design laws, and other pertinent areas. Forum participants will develop recommendations for how AMCP can advocate for clarification and modernization of these laws and regulations to advance the adoption of precision medicine.
