
## AMCP's Volunteer Leaders Gather to Discuss Strategic Plan, Key Issues


## Legislative Days Focuses on PIE Act, Addressing Fraud in Medicare Part D


## Volunteers, Staff Take Capitol Hill to Advocate for PIE Act, Efforts to Combat Fraud, Waste & Abuse

## Student Pharmacy Leaders Help Spread Word on Importance of Attending Annual Meeting





## AMCP eDossier System Supports Proposed PIE Act (H.R. 2026)

AMCP and stakeholders have been advocating for the early exchange of information between payers and manufacturers prior to FDA approval to support payer budget and formulary planning. The AMCP eDossier System payer community has had an increasing number of requests to manufacturers for preapproval information. In a recent survey, two-thirds of payers indicated manufacturer response to pre-approval requests via the System was the same or better than for non-participating manufacturers.
