Diplomat Program Overview

At a minimum:

- **Complete Year-End Diplomat Program Evaluation (email in late spring)**
- **On-going communication with faculty contact and/or AMCP Chapter Advisor**
- **Visit School/College of Pharmacy and meet with student pharmacists, AMCP chapter, faculty contacts**
- **If the School/College has Co-Diplomats, coordinate activities/reporting**

AMCP Chapter: Initial Phase

- Xavier student contact during AMCP Annual Meeting 2019; met and discussed starting an AMCP Chapter.
 - Diplomat identified that day!
- Needed to follow process for starting new organization at Xavier AND follow the AMCP guidelines for starting a new chapter
- Bylaws created for University using AMCP template and adding Xavier required language
- Required a Xavier advisor
- Required 10 AMCP members and a chapter executive board
- Student presentation to Xavier SGA for approval

AMCP Chapter: Challenges

- Xavier University leadership changed during the submission process causing rework and delays in approval
- Challenges with setting up bank account and obtaining EIN number
- COVID-19!
 - One of the AMCP chapter meetings was cancelled due to pandemic. The following meetings were virtual.

AMCP Chapter: Next Steps

- Research and consider switching banks that do not have high fees for a chapter with low funding (that is essentially just starting out)
- 2020-21 AMCP Chapter President organizing meetings and events based on Xavier guidelines for COVID-19.
- Working on speaker recruitment for 2020-21 school year.

AMCP Chapter: Diplomat Lessons Learned

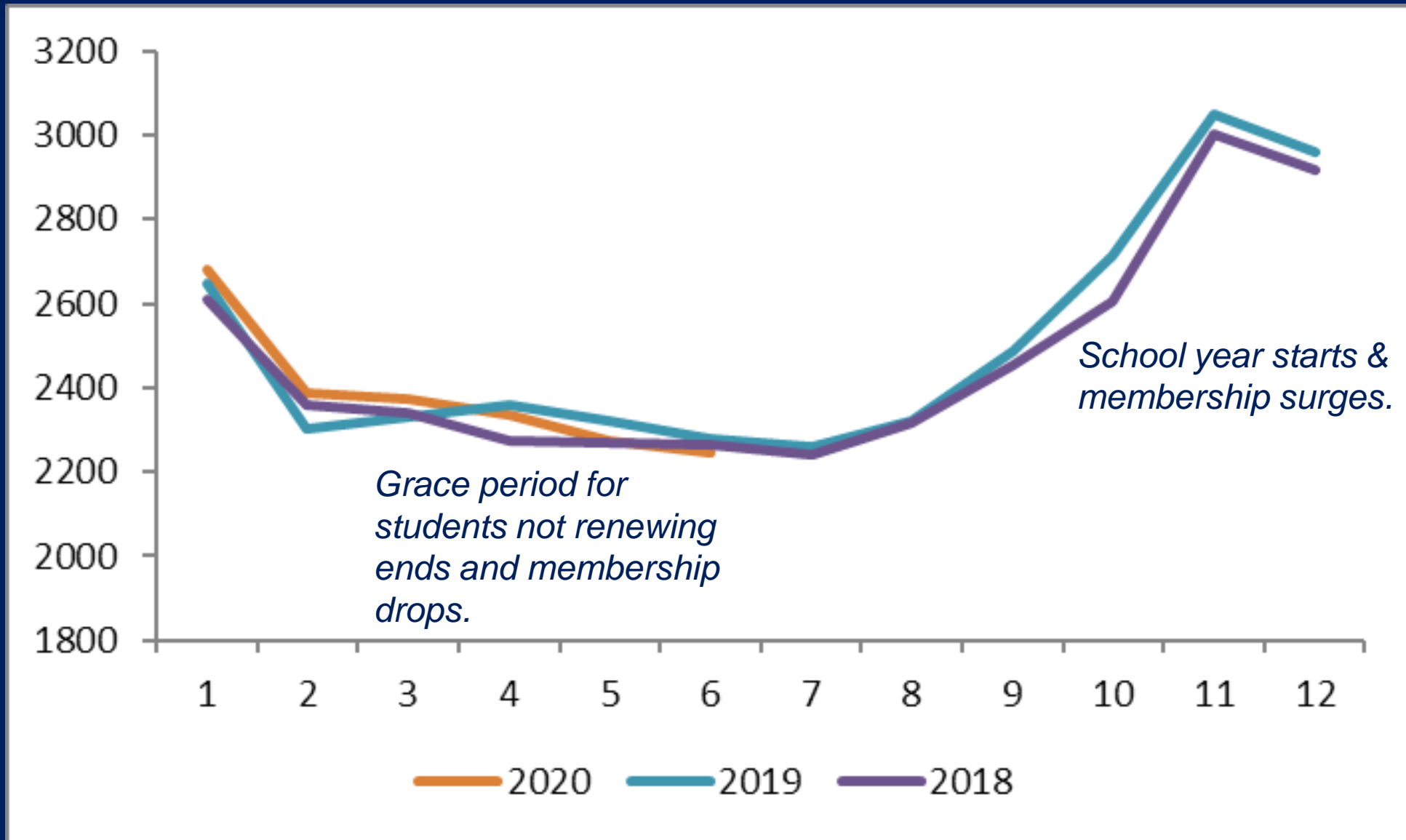
- Schedule check-in's with AMCP Chapter President and Advisor to track progress
- Advise on AMCP checklist items
- Encourage AMCP Chapter student leaders to delegate to their classmates!
- Assist with providing a “What is Managed Care?” overview (you add credibility!) and with inviting guest speakers.
- Be flexible, considering the COVID-19 requirements.

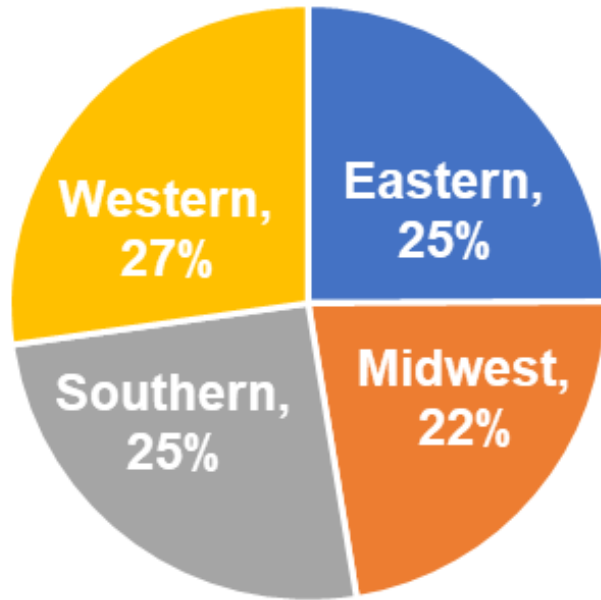

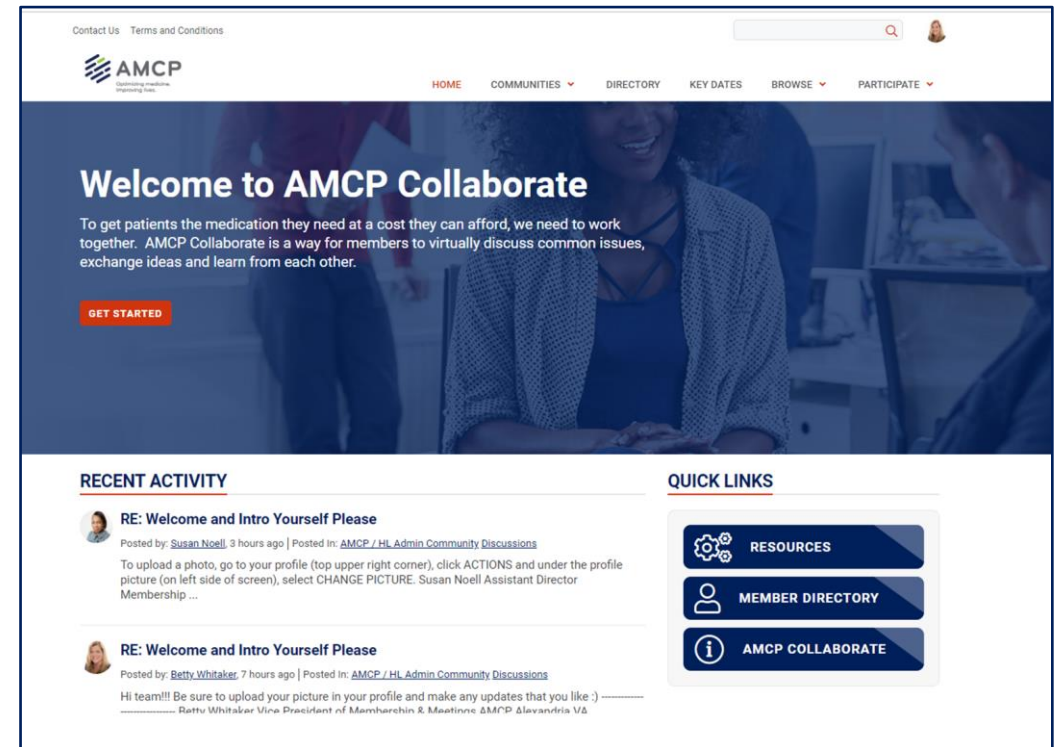
Student Pharmacist Chapters
