Several members of our Florida Affiliate Organization and the Student Affairs committee participated as judges in the AMCP P&T Competition held by the students at the University of Florida (UF). The competition saw a great turnout with ten teams fully entering the competition. It was very evident that the teams spent quite a bit of time on their submission materials and oral presentations with all teams performing an amazing job. The team selected as

the overall winner of the local competition then submitted their documents for the AMCP Foundation Annual National Student Pharmacist P&T competition. Although not chosen as a finalist for the national competition, the UF team did earn an honorable mention so we would like to say congratulations to this team which included: Elaine Altamura, Hope Fellows, Macy Boren, and Erica Alini 😊. Nice work team!

One of the goals of the Student Affairs committee is to promote the field of Managed Care and provide support to every Florida College of Pharmacy. The committee members have a vast amount of experience and can offer their knowledge and assistance to students wanting to participate in their local P&T competitions. We would love to see teams from all Florida Colleges hold a local competition in 2022 and hopefully produce a winner at the national competition!

### **Legislative Committee:**

The Florida Board of Pharmacy filed the following immunization bills, which facilitate vaccine administration.

- ❖ Bill HB 459/SB 494 authorizes pharmacists or pharmacy interns to administer to an adult any immunizations or vaccines listed in the Adult Immunization Schedule (AIS) by the Centers for Disease Control and Prevention (CDC), recommended by the CDC Advisory Committee on Immunization Practices (ACIP), or recommended by the CDC for International Travel.
- ❖ Bill HB 1063 authorizes a pharmacist to order and administer vaccines OR administer vaccines within the framework of a protocol under a supervising physician to individuals 3 and older.
- ❖ Bill SB 768 authorizes the administration to persons six years or older of immunizations or vaccines listed in the Child and Adolescent Immunization Schedule (CAIS) by CDC.
- ❖ Bill SB 898 authorizes pharmacists to order specified vaccines and removes the requirement that vaccines be administered within the framework of a written protocol under a supervising physician. The bill authorizes pharmacy technicians to administer immunizations or vaccines under the supervision of a certified pharmacist.
