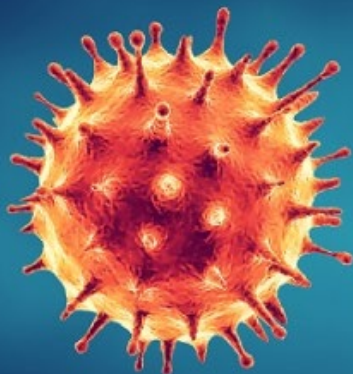

AMCP will host a (PIE) webinar sponsored, developed, and presented by G1 Therapeutics. Trilaciclib is an investigational myelopreservation therapy that may protect bone marrow stem cells from chemotherapy damage and reduce the incidence of neutropenia, anemia, and hospitalizations in patients with small cell lung cancer. This webinar will review clinical data and the value of trilaciclib prior to FDA decision for safety and efficacy.
