

BBCIC is a non-profit, multi-stakeholder, collaborative, scientific public service initiative conducting rigorous postmarketing observational research to monitor biosimilar products and novel biologics for effectiveness and safety in a real-world setting. This research provides health

plans, prescribers, and patients with the evidence they need and the reassurance they want to make informed treatment and coverage decisions. Through a distributed research network, BBCIC leverages large sets of medical and pharmacy data from over 100 million patients. Learn more at bbcic.org.
