- Gathering constituent data to identify key legislators in districts where our members reside for advocacy and engagement
- Finalizing Carolinas legislative resources to keep members updated on relevant managed care pharmacy legislation
- Continue to support AMCP legislative priorities.
 - Prescription Digital Therapeutics (Access to Prescription Digital Therapeutics Act of 2023 (S.723/H.R. 1458).
 - Value in Medicaid (Medicaid VBPs for Patients (MVP) Act (H.R. 2666)
 - Pharmacy Care (Equitable Community Access to Pharmacist Services (ECAPS) Act (H.R. 1770)





Committee Updates (continued)

Student Affairs Committee:

The Carolina's AMCP Affiliate - Student Affairs Committee recently established a monthly Engagement Survey in an effort to streamline effective tracking and documentation of our member's involvement with 7 targeted Pharmacy Schools across NC and SC. The short survey takes less than 5 minutes to complete and provides our Affiliate Chapter with key information about the various events or activities related to pharmacy student affairs that our members have participated in. The survey also serves as a way to gauge bandwidth for future student engagements, such as mentoring an interested pharmacy student. By having this information submitted electronically, we can efficiently export the data into our Pharmacy School Tracker, make updates to our Speaker Lists, and monitor progress towards our yearly goals. This tool is a simple way for the Carolina's AMCP Affiliate to visualize where our efforts are having the greatest impact on students. It will also help us to identify areas to target further, such as growing local AMCP Chapters at each of the targeted Pharmacy Schools, where students have expressed an eagerness to learn more about Industry and Managed Care Pharmacy.
