MEMBER SPOTLIGHT

Interviewed & Written by Michael Tom

Background Our member spotlight this quarter features Matthew Hymel, PharmD and Manager of Medicare Pharmacy Operations at the Blue Cross of Idaho in Boise. Matt attended the University of Louisiana while also working as a pharmacy intern at Walgreens, both in local retail and specialty. Post-graduation he completed a Managed Care PCY-1 Residency at Viva Health, a health plan headquartered in Birmingham, Alabama. During residency, he focused on Medicare Part D Benefits. This experience led him to his current role with Blue Cross of Idaho.

What is unique about your role?

My primary job is the management of the pharmacy operations for the government programs line of business: Medicare Advantage, Medicaid, and dual eligible plans. I'm heavily focused on administrative tasks with oversight of the PBM (pharmacy benefits manager) and our relationship with them. A lot of my day-to-day is much more centered in relationships with the PBM or with our internal stakeholders

When you interact with Medicare, what are you responsible for?

We have a monthly meeting with the CMS regional office that's assigned to us. We review high level updates. My focus is to comprehend all the Medicare regulatory updates through weekly memo releases, analyze

the regulatory update, and then work on implementation. I work alongside our Compliance team in meetings with our CMS assigned account manager.

What do you enjoy most about your work?

I enjoy the problem solving. There's really no set day-to-day, so every day is different. I set my own goals, work with my leaders to prioritize those goals, and then work with the team to implement those goals. It's individually driven and allows for flexibility. I also find that I have good work-life balance. [Blue Shield of Idaho] is a great employer to work for.

Are there any recent projects that you're able to talk about?

The IRA (Inflation Reduction Act) brings a lot of provisions related to the Part D benefit. The PBM is going to do some heavy lifting with implementing. Implementing changes requires close collaboration with my Medicare pharmacy team to ensure we understand the guidance, its impact. I ensure there is clarity on what the PBM is implementing and what BC Idaho should be implementing. We communicate these changes with other stakeholders at Blue Cross in advance and work closely with our compliance team. I'm learning a lot of new material to

keep up with changes.

What innovations have you seen at Blue Cross of Idaho?

One interesting thing I've seen since coming here is innovative direct contracting with manufacturers for drug rebates, specifically medical drugs. While Idaho is a small market, Blue Cross Idaho is one of the bigger plans so we are able to implement preferred drug changes quickly and have uptake in the provider community. I think there's a benefit to both the plan and the member because the member does get the benefit of lower cost.



What do you think needs to be changed in the scope of managed care?

I hesitate to comment on the scope of the industry because I don't consider myself an expert, but I think one of the primary areas that everybody has focus on is "how do we control drug costs while still maintaining access?" How do we, as an industry, (cont.)

address these growing costs, maintain access, and ensure that patients get the right drug at a reasonable cost? I think that with the way that the government's been with the Inflation Reduction Act, it focuses on Medicare negotiating drug costs, kind of a controversy. I think we're just going to continue to see this as an interesting challenge.

Based on the trajectory of your career what possible roles did you feel empowered to pursue?

I really found the passion for operations roles. I really like the operations and regulatory oversight, so moving into more of a leadership role with a focus on that. I've been given a good set of tools here in this current role to pursue more strategic based roles where you're looking at the bigger picture, like in a director role. I would perceive myself staying in the health plan space. Other items include industry and other parts of the managed care, PBM world.

Since you're on the newer side like you said, what is some advice that you have for students or new practitioners who are interested in pursuing managed care?

Many organizations are looking for people that have some baseline experience, so I think the most important thing is networking, getting to meet people, and know people. AMCP serves a great function, especially when you're in school. I didn't go to a school that was involved in AMCP, but when it came time for rotations, I sought out managed care experiences or opportunities within an organization I worked with that has ties to managed care. Even in a retail setting, I worked on a medication adherence project that was tied to quality improvement measures. This was my introduction to payers and the world of quality improvement. Not every managed care experience is going to start at PBM or a health plan. Just be open to those opportunities wherever you may find them.

Tell us something people may not know about you.

I love to cook food, especially Cajun food. From Louisiana, embracing my roots there so I'm a pretty good cook.



Is there anything you wanted to share with the membership?

I don't have any groundbreaking insight. I would say that after being in this industry for three years, I still I think it's always important to remember who we are here to serve and that is our patients and members. So regardless of what your role is in managed care, a payer PBM, industry, or a health system, it's always about remembering our patients/members are the reason we're all here. I like the Medicare world, because it is very member centered and they have a lot of protections that the commercial world follows. My kind of message to put patients first.

2. NW AMCP New Practitioner Award

This award recognizes a NW AMCP Affiliate member who has made meaningful contributions to managed care pharmacy within 5 years of graduation from first professional degree program in Pharmacy, Medicine, or Nursing.

3. NW AMCP Lifetime Achievement Award

This award recognizes a NW AMCP Affiliate member who has made exceptional and sustained contribution to AMCP on a national and regional level over at least a 5-year period. Their contributions align with AMCP's mission "to improve patient health by ensuring access to quality, cost-effective medications and other therapies."

4. NW AMCP Distinguished Service Award

This award recognizes a NW AMCP Affiliate member who has made exceptional and sustained contributions to the affiliate. Their contributions align with the Affiliate's mission "To serve the AMCP membership in the states of Alaska, Hawaii, Idaho, Montana, Oregon and Washington."

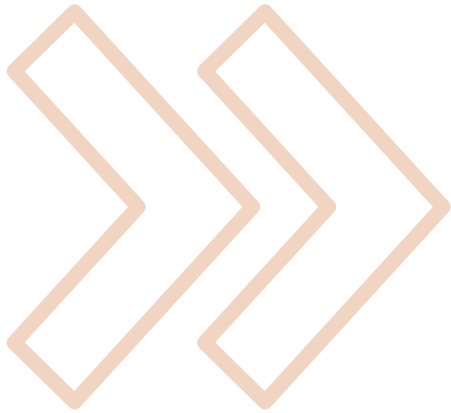
