RE: Student Pharmacy Programs

The Great Plains Affiliate of the Academy of Managed Care Pharmacy (AMCP) representing Colorado, Iowa, Kansas, Missouri, Nebraska, North Dakota, South Dakota and Wyoming, in partnership with Gilead and LEO Pharma, is offering Student Pharmacy Programs for AMCP Affiliate Student Members. These opportunities aim to provide student pharmacists exposure to a day in the life of a pharmaceutical manufacturer. Air travel, meals, and overnight accommodations will be provided by the pharmaceutical manufacturer.

Student Pharmacy Program opportunities:

- **LEO Pharma Student Shadowing Day** (August 14-15th, 2024)
 - Available to one (1) pharmacy student from the respective AMCP Affiliate
- **Gilead Student Pharmacy Program** (September 10-11th, 2024)
 - Available to two (2) pharmacy students from the respective AMCP Affiliate

These partnerships align with the educational mission of AMCP, Gilead, and LEO Pharma. To qualify for the Student Pharmacy Program(s), you must be a P2 – P4 PharmD student at the time of the program (i.e., have not graduated as of August 2024), at one of the accredited Colleges of Pharmacy within the AMCP Great Plains Affiliate region, a current member of AMCP, and have completed the application form. Your application must include a brief essay on what you will gain from attending the Student Pharmacy Program and how it will contribute to your professional goals related to pharmacy. If you are chosen to attend the Student Pharmacy Program, you will be asked to present a summary of your experience at AMCP Nexus (in-person or virtual) and at a future AMCP Affiliate event and/or newsletter.

Members of the AMCP Great Plains Affiliate Board will conduct the application review. The evaluation will be based on the submitted essay, completed application form, supporting documents, and your CV. The Board will select up to **three (3) students** (1 student for LEO Pharma, and 2 students for Gilead) from accredited Colleges of Pharmacy within the AMCP Great Plains Affiliate region.

Please Note: The AMCP Great Plains Affiliate Board will review all applications and make an announcement of winners on or before June 21, 2024. Thus, late applications will not be accepted.
