



## AMCP Affiliates Accepting Applications for 2025 LEO and Gilead Student Pharmacy Programs

Each of AMCP's 13 affiliates, in partnership with Gilead and LEO Pharma, is accepting applications for Student Pharmacy Programs for AMCP student members. These programs offer students an inside look at a pharmaceutical manufacturer's day-to-day operations. The visitation is onsite at the manufacturer's facility, and the pharmaceutical manufacturer provides air travel, meals, and overnight accommodations.

### Student Pharmacy Program Opportunities

- Gilead Student Pharmacy Program – Foster City, CA (September 9-10, 2025)
  - Available to two (2) pharmacy students from each respective AMCP Affiliate
- LEO Pharma Student Shadowing Day – Madison, NJ (September 17-18, 2025)
  - Available to one (1) pharmacy student from each respective AMCP Affiliate

### Eligibility Requirements

To qualify for the Student Pharmacy Program(s), you must:

- Be a P2 – P4 PharmD student at the time of the program (i.e., have not graduated as of August 2025)
- Be enrolled at one of the accredited Colleges of Pharmacy within the AMCP Affiliate region
- Be a current member of AMCP
- Have completed the application form.

### Application Process

To be considered, students must submit their application to the AMCP affiliate that covers their region. A list of AMCP affiliates, their covered states, and email addresses is included as Addendum A. **It is important to identify your affiliate and only submit your application to that affiliate.**

- Your application must include:
  - A brief essay on what you will gain from attending the Student Pharmacy Program and how it will contribute to your professional goals related to pharmacy
  - Completed application form
  - Supporting documents
  - Your CV

If you are chosen to attend the Student Pharmacy Program, you will be asked to present a summary of your experience at AMCP Nexus (in-person or virtual) and a future AMCP Affiliate event and/or newsletter.

### Application Review and Selection

Members of each respective AMCP Affiliate Board will conduct the application review. The evaluation will be based on the completed application form, essay, supporting documents, and your CV. The Board will select: 1 student for LEO Pharma and 2 students for Gilead.

## Important Dates

- Application Deadline: Completed applications must be submitted to the appropriate AMCP Affiliate's email address no later than **12pm ET on May 27, 2025**. Late applications will not be accepted.
- Announcement of Winners: Your AMCP Affiliate's Board will review all applications and announce winners on or before **June 24, 2025**. If you have any questions, please do not hesitate to contact your affiliate at their respective email address.
