Affiliate Meeting at AMCP Annual







Past Events Highlights: ISPOR 2025 HIGHLIGHTS

"Collaborating to Improve Healthcare Decision Making for All: Expanding HEOR Horizons" was the theme of ISPOR 2025, held May 13-16 in

Montréal. ISPOR envisions a global collaborative effort using lessons from HEOR research to improve health care decisions and transform systems "by fostering cross-sector collaboration among researchers, clinicians, policymakers, and industry leaders," to empower data-driven, patient-centered, and equitable decision making. Collaboration is essential in our increasingly complex healthcare system. ISPOR meetings bring together a wide array of stakeholders and researchers from around the world. "By making HEOR insights more accessible and actionable, the field can shape policies, optimize resource allocation, and advance value-based decision making," ISPOR says.

The featured plenary session, "Drug Price Controls—What Are the Unintended Consequences to Innovation?" featured our own Sean Sullivan and other experts from academia, industry, and HEOR research from both sides of the Atlantic. The session was one day after President Trump's "MFN" edict, and the panelists, still processing that information, opined on price controls in general, reference pricing, and the potential impact of its adoption by the U. S. Rather than relying on rigid price controls, options such as price transparency, outcomes-based pricing, and a structured U. S. HTA framework, as proposed by the Aspen institute.

Acknowledging that the U. S. bears the majority of drug R&D costs, the panel explored the complex relationships between pricing, access, affordability, and venture capital funding. They called on ISPOR members to up their game in publishing robust research, communicating the findings to policy makers, and advocating for balanced solutions that protect innovation and patient access.

The second plenary explored "Evolution of Evidence—Innovating for the Future of HTA" from a Canadian perspective, with experts from the French Canadian INESSS and Canada's Drug Agency (formerly CADTH) presenting perspectives from Québec and Ontario. A patient representative and an academic researcher rounded out the panel, which explored patient perspectives, equity, environment, and ethics, and the transformation of HTA, internationally and through a Canadian lens, examining key topics such as RWD/RWE, implementing expanded definitions of value and taking a whole health approach to HTA. A third plenary addressed "Balancing Speed and Scientific Rigor—Patient-Centered Methodologies for Surrogate Endpoints in Accelerated Access," a hot topic for managed care pharmacists.

The rapidly expanding role of artificial intelligence also featured prominently in sessions including "Using LLMs to Simplify Real-World Evidence Research," "Transforming LLMs Into Reliable Research Tools," "Driving Evidence-Based Medicine Forward With Generative AI (e engineering in HEOR research. Many posters involving AI were also presented.

Other important themes included IRA impacts, patient centric research, expanding the definition of value, and improving health equity and access. The meeting also introduced our own Beth Devine as incoming President Elect.

A digital conference pass for all sessions is now available here. If you've never been to an ISPOR meeting, it's a great experience that will broaden your horizons and challenge you to think. The next meetings are November 2025 in Glasgow and May 2026 in Philadelphia. ISPOR also has many Webinars on a variety of topics that are free to members.
