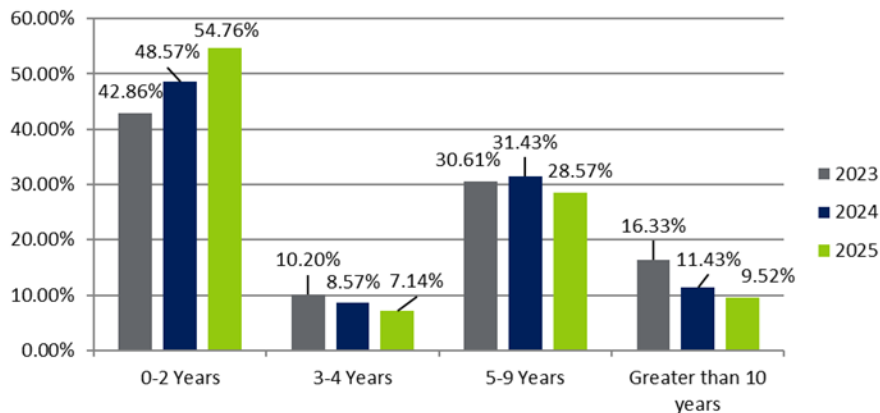

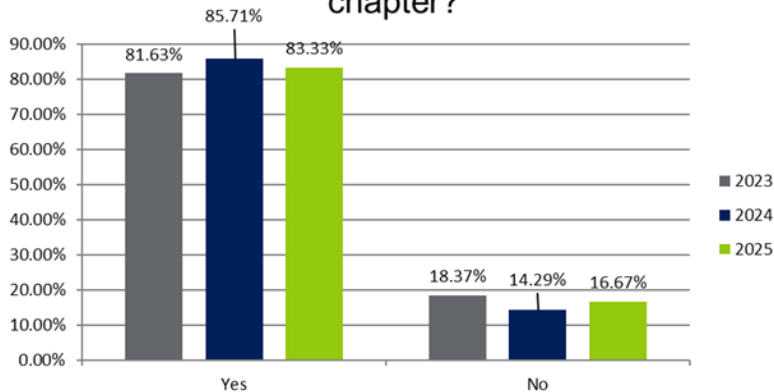

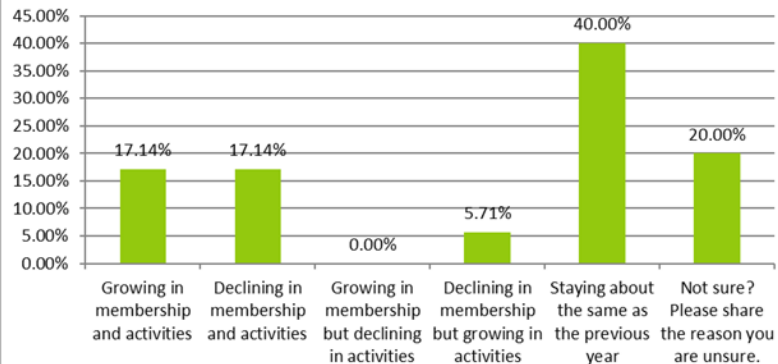

Does your school have an AMCP student chapter?



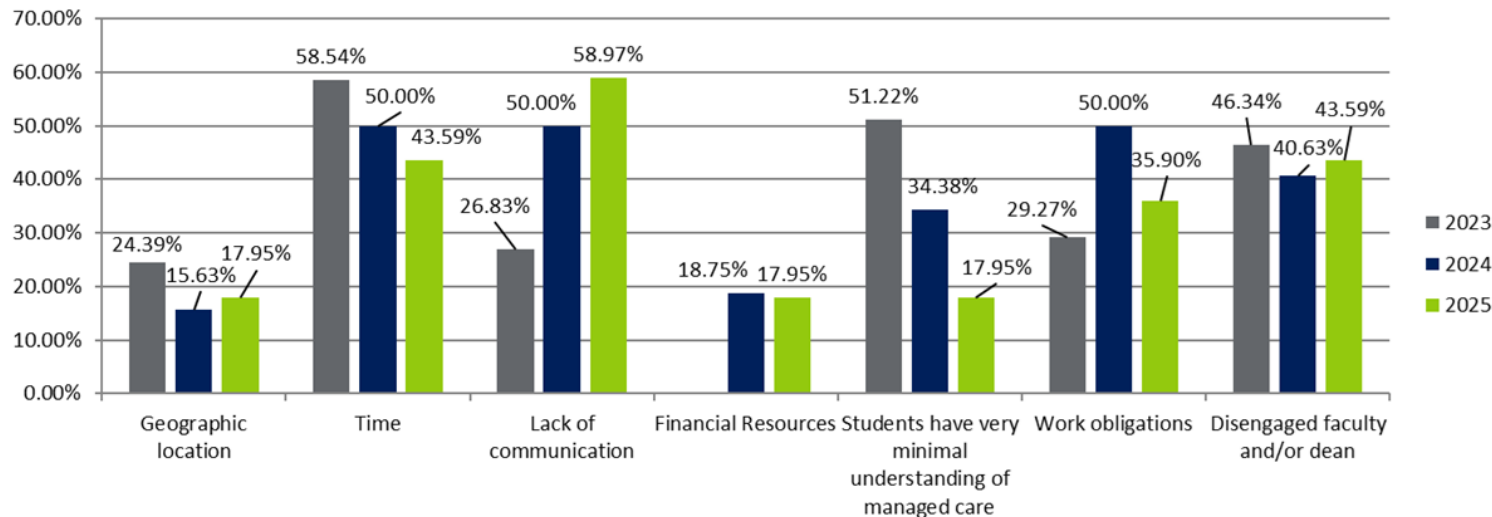
Would you describe the AMCP Student Chapter(s) at your assigned school(s) as:
