

## »»» INSIGHTS FROM THE AMCP FLORIDA LEGISLATIVE COMMITTEE



Our Legislative Committee reviewed two key companion bills in the 2025 legislative session with significant implications for Managed Care pharmacy.

### Senate: S1124 Pharmacist Selection and Reimbursement

This bill was sponsored by Sen Corey Simon (R). It was filed on 02/25/25 and referred to several committees. It died in Banking and Insurance committee on 06/16/25 ([Link to Bill](#))

### House: HB 941 Pharmacist Selection and Reimbursement

This bill was sponsored by Rep. Shane Abbott (R). It was filed on 02/24/25 and referred to several committees for review. It did not make it out of the Health Care Facilities & Systems Subcommittee, so it essentially died on 06/16/25 ([Link to Bill](#))



## Summary

These bills sought to empower covered individuals to select in-network pharmacists, ban reimbursement denials for equivalent services rendered by pharmacists within their scope of practice versus other health professionals, and include pharmacists in network adequacy measures. The House and Senate bills contained similar/identical language. We are likely to see these bills, with similar language, be filed again in this upcoming legislative session.
