Section 1:

AMCP Diplomat Program

Diplomat Operations

Purpose

The Diplomat Program is designed to:

- Raise faculty awareness of AMCP and managed care pharmacy;
- Expose student pharmacists to career opportunities in managed care pharmacy; and
- Enhance communication between the Schools/Colleges of Pharmacy and local AMCP members.

Diplomat Program Overview

The AMCP Diplomat Program is a great resource for student pharmacists because it puts them in contact with real-world managed care professionals! How does it work? An AMCP member volunteers to be assigned to a school/college of pharmacy to serve as a resource on managed care pharmacy information and opportunities. Diplomats can speak or find speakers and assist with projects or meetings. Members of the AMCP Schools of Pharmacy Relations Committee provide oversight of the AMCP Diplomat Program. Four Diplomat Regional Directors serve as liaisons between the Schools of Pharmacy Relations Committee and the Diplomats. The goal is to have at least one Diplomat assigned to each school/college of pharmacy. Some schools/colleges have two Diplomats who share the responsibility.

Diplomat Appointment Process

Diplomat Qualifications

Diplomats must be AMCP members, have a sense of volunteerism, and desire to further the mission of AMCP with the schools/colleges of pharmacy. The Diplomat will need to exhibit leadership skills to develop and foster a positive relationship between AMCP and the schools/colleges of pharmacy. The ideal Diplomat must have a commitment to AMCP and student pharmacists. Strong communication skills and regular follow-up are key to success and achieving the goal of increasing awareness and activity at the respective school/college of pharmacy.

The Diplomat will help create a greater understanding and appreciation of managed care pharmacy among students and faculty members; develop opportunities to facilitate the incorporation of managed care pharmacy concepts into curricula; and engage AMCP student pharmacist members by serving as a liaison between the schools, local AMCP members, and AMCP.

Diplomat Appointment and Term

AMCP members who wish to volunteer to serve as the Diplomat for a specific school/college of pharmacy, preferably located near where they live, may apply online through the AMCP website (<https://www.amcp.org/resource-center/group-resources/diplomats-resources/diplomat-application>). Once the request is received, AMCP staff will review the application, notify the AMCP member of their appointment, and forward tools to assist the Diplomat.

Diplomats will serve in this role until they are no longer able to fulfill the responsibilities of the position or have not met the minimum duty requirements. To reconfirm their commitment each year, Diplomats must complete the annual Diplomat Survey and submit the Diplomat Activity Report by June 30. As part of the survey, Diplomats will indicate whether they wish to continue serving for the upcoming academic year. AMCP may consider chapter needs, including schools with members awaiting Diplomat opportunities or those with Co-Diplomats for consecutive years, when reviewing continued service. Diplomats choosing to step down will be encouraged to provide transitional support to the incoming Diplomat.

Diplomat Responsibilities

The Diplomat will be required to do the following (at a minimum):

- Complete the Annual Diplomat Survey (sent via email in mid-summer)
- Submit the [Diplomat Activity Report form](#) at least once every academic year
- Have ongoing communications with a faculty contact and/or AMCP Chapter Advisor regarding AMCP activities and resources.
- Visit with the school/college of Pharmacy and meet with student pharmacists, AMCP chapter and/or faculty contacts; and
- If the school/college has Co-Diplomats, coordinate activities/reporting to ensure requirements are completed.

The Diplomat is strongly encouraged to do the following:

- Encourage the faculty to learn more about managed care pharmacy.
- Distribute AMCP materials to key contacts at the school.
- Participate in Career Day at the school.
- Interface with and be a resource for AMCP Student Pharmacist Members and the AMCP Student Chapter (if one exists at your school).
- Distribute managed care internship and residency information.

- Offer to present a lecture on managed care pharmacy or secure a speaker.
- Encourage the formation of an AMCP Student Chapter, if one does not already exist.
- Foster communication between schools with and without AMCP Student Chapters.
- Identify student pharmacist leaders who may be potential AMCP Student Pharmacist Committee members and report to AMCP staff.
- Attend the Diplomat Meeting at each of the AMCP national meetings.
- Encourage faculty to join AMCP.
- Link local AMCP members and other managed care pharmacy professionals with student pharmacists.
- Promote the Student Pharmacist Center on the AMCP website – www.amcp.org/students
- Participate in the national meetings & conference buddy program.

Diplomat Reports and Evaluations

Diplomat Annual Survey

In the Spring, Diplomats will be sent a survey to complete. This survey is a time to reflect on the opportunities and challenges you encountered during the year. It is also a mechanism to let staff know what tools or resources you could have used to make it easier for you to fulfill your responsibilities.

Diplomat Program Participant Descriptions

AMCP School of Pharmacy Relations Committee

The AMCP School of Pharmacy Relations Committee oversees the Diplomat Program. They develop resources and education to assist the Diplomat in their role.

Diplomat Director

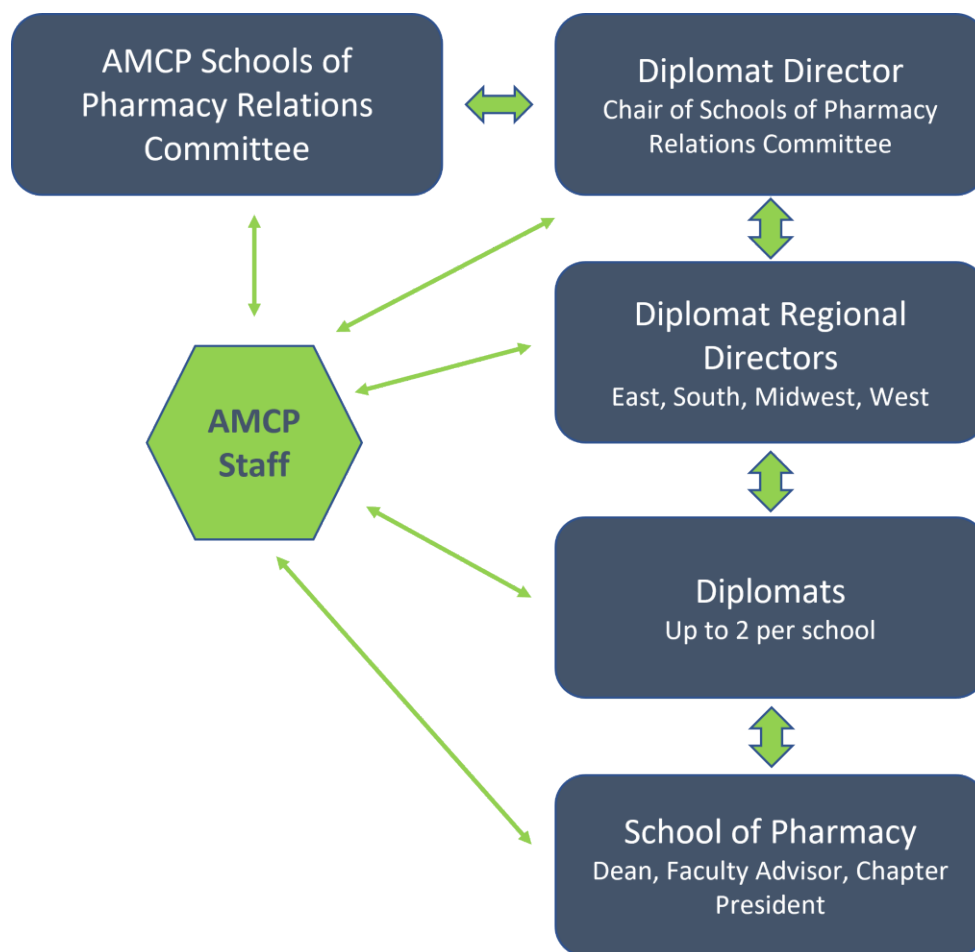
The Schools of Pharmacy Relations Committee Chair acts as the Diplomat Director. They oversee the Diplomat Program and conduct the Diplomat Meeting at each national AMCP meeting. In addition, the Diplomat Director serves as a resource to the Diplomat Regional Directors, the Diplomats, and the AMCP staff liaison.

Diplomat Regional Directors

Four Diplomat Regional Directors (East, South, Midwest, and West) are the primary conduits between the Diplomats in their region and AMCP staff/headquarters. In addition, the Regional Directors also serve as a mentor for the Diplomats in their region.

AMCP Staff

The AMCP Manager of Student Pharmacist and New Practitioner Programs serves as the Diplomats' primary contact at AMCP headquarters. Staff will provide tools and information to assist the Diplomats and provide periodic reports and evaluations to the Schools of Pharmacy Relations Committee.

Diplomat Best Practices

AMCP Student Chapters

Note that some chapters have chapter-only members. These are not considered AMCP members and do not receive benefits.

AMCP Foundation National P&T Competition

The local and national Competition is intended to allow students to hone various skills, including critical analysis, presentation, and research skills. More importantly, the Competition will allow students to view different styles and processes used in effective formulary management and provide exposure to and a working knowledge of AMCP's Format for Formulary Submissions. Students must have national membership to participate.

The deadline for submitting the Chapter's P&T Competition registration form is generally between mid-October to early November.

Chapters often host local competitions within the school, which is a great membership recruitment strategy. Many Diplomats act as judges for these competitions. In addition, the winning local team is often submitted on behalf of the chapter in the National P&T Competition. The deadline for Chapter submission is late January/early February. Eight (8) AMCP Chapters from the submissions will be selected to compete at the national Competition held in conjunction with the AMCP Annual Meeting & Expo held in the spring.

Chapter Collaboration Program (Chapter Collab)

The purpose of Chapter Collab is to provide a forum for student pharmacists to collaborate, exchange ideas, and network with students from other chapters. Whether it be explaining managed care pharmacy to first-year students, hosting a Pharmacy & Therapeutics Competition, or recruiting new members, we all face similar challenges.

New chapters may struggle to figure out best practices while established chapters seek new ideas and programs for their members. Although student chapters may be geographically close, members

may not have the opportunity to collaborate with one another. Through Chapter Collab, chapters will have a chance to share resources, achieve goals that cannot be achieved alone, and learn about best practices. As they learn from one another, chapters will be able to gather, modify, and implement new programs to achieve their goals and overcome their challenges.

Chapter Leadership Academy

AMCP Chapter Officers are invited to participate in the half-day AMCP Chapter Leadership Academy held each year in conjunction with the AMCP Annual Meeting & Expo. Up to four Chapter leaders will learn the needed “how-to’s” to ensure a successful AMCP Student Chapter. In addition, a limited stipend to apply for travel and hotel accommodations is provided to two of the four leaders from each Chapter.

The half-day event aims to arm AMCP chapter officers with tools that can be used upon return to their chapter. It is recommended that the chapter officers who attend are those who will hold office in the upcoming academic year. The AMCP Chapter Leadership Academy features a keynote address, chapter projects, and networking with other chapter leaders. Invitations will be sent to each faculty advisor in mid-January.

AMCP Membership Highlights

AMCP Membership Categories

AMCP has several membership categories that provide a professional home for those who support the AMCP vision and mission.

- **Active Member** – Pharmacists, Physicians, Nurses, and Physician Assistants who are licensed or eligible for licensure to practice in the United States. Active members hold full voting rights and may serve on all AMCP committees and run for the Board of Directors.
 - **New Graduates** – Members who have graduated in the last two years receive a 50% discount off dues.
- **Student Pharmacist Member** – Must be enrolled full-time in a school or college of pharmacy accredited by the Accreditation Council for Pharmacy Education (ACPE). Student Pharmacist Members may serve on a number of AMCP committees but may not vote in AMCP elections.
- **Resident/Fellow/Graduate Student Member** - Must be enrolled full-time in a graduate/postgraduate school program recognized by ACPE or practicing full-time in a residency or fellowship related to pharmacy or managed care pharmacy. Those in this membership category may serve on a number of AMCP committees and vote in AMCP elections.
- **Associate Member** – Healthcare and related professionals who support the mission and objectives of AMCP but do not hold a license as a pharmacist, physician, nurse, or physician assistant. Those in this category may serve on committees but do not vote in elections.

AMCP Leadership & Representation

AMCP members are well represented by members in leadership roles. AMCP Chapter Officers are encouraged to get to know their elected and appointed representatives.

- The **AMCP Board of Directors**, composed of nine Active elected members and the AMCP CEO, provides strategic direction for AMCP and representation for all members.
- **AMCP Committees** direct AMCP's activities, ranging from professional practice to planning the educational programming for AMCP national meetings.

AMCP Resources and Publications

AMCP Meetings & AMCP Learn

AMCP National Meetings

AMCP hosts two national meetings yearly: the AMCP Annual Meeting in the spring and AMCP Nexus every fall. Both events draw thousands of the nation's top managed care pharmacy leaders and feature renowned keynote speakers, an array of cutting-edge educational sessions, extensive networking opportunities, and an exhibit hall of companies and organizations sharing their latest innovations and services. Some student-related activities relevant to your school chapter include the Chapter Leadership Academy at the AMCP Annual Meeting and Residency Showcase at AMCP Nexus. There are also Diplomat meetings at each conference, and you are encouraged to attend student networking events and serve as a Conference Buddy.

AMCP Regional Meetings

The [AMCP Affiliate Program](#) provides a mechanism for AMCP members to engage at the local, state, and regional levels. AMCP affiliates provide a much-needed forum for education, networking, and outreach among local pharmacists, other healthcare professionals, students, and schools. Affiliate membership is a member benefit, and members are automatically assigned based on their mailing address. In addition to their primary affiliate, members can add other affiliates to their profile under the “Other Affiliate Membership” section.

Affiliates are entirely member-run, and there are numerous opportunities to volunteer:

California AMCP — Covers the state of California.

Carolinas AMCP — Covering the states of North Carolina and South Carolina.

Florida AMCP — Covers the state of Florida.

Georgia AMCP — Covers the state of Georgia.

Great Plains AMCP — Covering the states of Colorado, Iowa, Kansas, Missouri, Nebraska, North Dakota, South Dakota and Wyoming.

Mid-Atlantic AMCP — Covering the states of Delaware, Maryland, Virginia, West Virginia, and the District of Columbia.

Midwest AMCP — Covering the states of Illinois, Indiana, Michigan, Minnesota, and Wisconsin.

Mid-South AMCP — Covering the states of Mississippi, Tennessee and Alabama.

Mountain West AMCP — Covers the state of Nevada and Utah.

Northeast AMCP — Covering the states of Connecticut, Maine, Massachusetts, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, and Vermont.

AMCP Fundamentals of Managed Care Pharmacy Certificate Course

This [online program](#) provides an updated, comprehensive introduction to basic concepts in managed care pharmacy. This program is designed for pharmacists, pharmacy residents, managed care/managed markets team members, and other individuals who are interested in expanding their understanding of managed prescription drug benefits.

In the [professional version](#), pharmacists can earn 8.75 contact hours (0.875 CEUs) of continuing pharmacy education (CPE) credit. The student version is designed for pharmacy students and allied health professionals interested in expanding their understanding of managed prescription drug benefits. Several schools use this as part of their program for students. Bulk pricing is available.

AMCP Policy Issues & Advocacy

AMCP advocates on behalf of managed care pharmacy to ensure that the interests of the members and the patients they serve are considered in federal and state health care policy decisions that could impact the profession. AMCP also represents managed care pharmacy in meetings with federal agency officials and by submitting comments on proposed rules and regulations.

- **Policy Positions** - AMCP has developed policy and established position statements on many issues affecting managed care pharmacy and the pharmacy profession in general. If you have ever wondered what AMCP may “think” about an issue, you can find out by reviewing the [AMCP Policy Digest](#). The Policy Digest lists short paragraphs documenting AMCP’s position on professional practice and policy issues.
- **Where We Stand Position Statements** - The Where We Stand series represents AMCP’s position statements on various issues impacting managed care pharmacy. - **Advocacy** - Just as national and state laws and regulations regulate the traditional practice of pharmacy, so too is pharmacy practice in managed care. It is important for you to be aware of and understand proposed legislation and regulations that affect managed care pharmacy.
