The AMCP Florida-Puerto Rico Affiliate is offering scholarships for up to 5 AMCP Student Pharmacist Members to attend the AMCP Nexus Meeting in 2026. Scholarship recipients will receive up to \$500 each to help cover personal costs related to registration, lodging, and travel.

Criteria for Scholarship Eligibility and Disbursement:

- Student Pharmacist Member of the AMCP national organization.
- Currently attending a college of pharmacy in Florida or Puerto Rico, under good academic standing.
- Attendance of AMCP Nexus meeting sessions with a written summary of your favorite session.
- Attendance and documented signature at the FL-PR AMCP Affiliate meeting at the AMCP Nexus Meeting.
- Students will be required to complete a W-2 form (if a U.S. citizen) and a disbursement form within 1 month after the meeting in order to qualify for reimbursement.
- Note that scholarship funds are for recipient expenses only. These funds are not intended to cover the cost of travel or lodging arrangements for other students or colleagues.

The scholarship application window is open from August 26th, 2026 to September 11th, 2026. Please submit this form and upload your most current CV by August 26th at 11:59PM EST.

Note: The amount and number of scholarships provided by the AMCP FL-PR Affiliate for AMCP meetings may vary for future meetings.

Ranking Criteria: AMCP Florida Board members will conduct the applicant review. The evaluation will be based on **both** submitted essays, completed application form, and submitted CV. No letter of recommendation required.
